Participation Requirements:

- As with the conferences offered on the 5th floor, participants do not need to register in advance to attend presentations at the Exhibitor Presentation Space. **Admission is on a first-come, first-served basis, up to the room’s maximum capacity.**
- As presentation content is not reviewed or evaluated by the ODQ, **participants do not receive a continuing education credit (CE credit) for attending.** However, attending the exhibition provides 1 CE credit.
- **The maximum capacity is 54 participants.** For safety reasons and in accordance with the Fire Safety Code, no additional chairs may be added.
- Demonstrations or treatments involving patients, live models, or animals are strictly prohibited.
- Exhibitors must adhere to their **reserved 25-minute presentation time slot, with 5 minutes reserved for setup.** If the exhibitor is absent more than 10 minutes after the scheduled start time, the presentation will be automatically cancelled.
- The exhibitor is fully responsible for any additional costs associated with the use of equipment not included in the standard setup. Exhibitors must also provide, in advance, details of any audiovisual requirements not included in the standard equipment, in accordance with the terms and conditions established by the official JDIQ supplier.
